WHAT TO EXPECT:

- Provide appropriate specialized developmental care and instruction for children and youth in one or more Child & Youth programs. This includes the provision of guidance, assistance, and mentoring for the CY Program Assistants.
- Duties may include assisting in the child's arrival and departure from the center, diapering, feeding, toileting, resting, etc.; developing and assisting with games and learning activities; observing and evaluating development levels and maintaining records and other related duties.
- Other duties may be assigned.

WHAT YOU NEED TO KNOW:

- **GSE-02 – Entry Level:** The primary function of this position is to serve as a trainee assisting higher-level employees to provide appropriate developmental care and instruction for children in the Child Development Center. Applicant must be 18 years of age at the time of appointment and be a high school graduate or equivalent (GED). Must be able to lift up to 40 pounds and successfully pass the required security and health checks.
- **GSE 03 – Intermediate Level:** The grade level of this position represents the intermediate level for childcare positions. Performs many difficult childcare tasks using training and experience. Training will be of a progressively responsible and specialized nature associated with the childcare and development operations. In addition to meeting the requirements of the GSE-02, applicant must have six (6) months experience working with children or youth in a child or youth setting AND completion of child abuse modules and modules 1-3 of the Department of the Navy (DON) Standardized Module Training. Knowledge of basic child and youth development principles as they relate to children and youth's physical, social, emotional and intellectual development. Ability to plan and organize work and to interpret a curriculum or activity plan and follow written instructions.
- **GSE-04 – Target Level:** Must possess one of the following: A Child Development Associate (CDA) credential or Military School Age (MSA) credential OR completion of the DON Standardized Module Training AND 12 months of experience working with children and youth OR a 2-year degree in Early Childhood Education, Child Development or related field of study. Note: If the incumbent is hired at the GSE04 target position, the incumbent must complete the Navy module program within 18 months.
- Must possess organizational skills necessary for program planning and scheduling. Able to speak, read and write English and possess strong interpersonal skills.

CONDITIONS OF EMPLOYMENT:

- **Must be at least 18 years of age and MUST provide proof of High School Diploma or equivalent, and any additional education, certification, and or training as required prior to placement. Conferred degree must be awarded from an accredited school, college, and/or university. If your degree has not been awarded by an accredited school, you must also submit a degree evaluation.**
- **Must meet Federal Employment suitability requirements and successful completion of background investigation.**
- **Ability to favorably pass pre-employment physical, provide evidence of immunization and be free from communicable disease and ability to favorably pass pre-employment drug screening.**

OTHER INFORMATION:

- **Participation in the Direct Deposit/Electronic Fund Transfer within 30 days of employment is required.**
- **We utilize E-Verify to confirm selectee's eligibility to work in the United States. The Department of the Navy (DON) is an Equal Employment Opportunity Employer. The discount will apply to children enrolled in a Child Development Center, School Age Care (before and/or afterschool care and summer camp), 24/7 Center or Child Development Home program. Employees with multiple children enrolled will have the 100% discount apply to the child with the highest fee and will continue to receive the standard 20% multi-child discount for any additional children. The discount is for any installation full-time, part-time, and flexible staff member working a minimum of 15 hours per week.**
