Risks to you and to your institution?


Do you have time to develop a solid proposal?



Develop and submit proposal

Review the sponsor's submission requirements – provide **proposal checklist**

- **Due date**; how will the proposal be submitted (electronically? Hard copy? Special requirements)
- **Cost sharing**/matching
- Budgetary **limitations** (e.g. salary cap, overhead, restrictions on certain costs)
- Develop a reasonable and appropriate **budget** (calculating salary – base salary; effort calculated on person months; fringe benefits; overhead). Significant over- or under-estimating suggests the PI may not understand the scope of the work.
- **Page limitations**, submission mechanism
- **Plans** for Responsible Conduct of Research, data security, data safety and monitoring, management/sharing
- Any other restrictive language and/or unusual requirements
- Sub-award Consortium Agreements
